Requirements: The intern would assist in the management of the program of record safety program. The intern would be integrated in the day-to-day operations of the ESOH program.

The intern shall monitor, comply, and manage with a system safety process in accordance with MIL-STD-882E throughout the development to ensure the program of record and its independent capabilities are safe to operate through-out the system life cycle. The system safety process shall address the methods to identify and evaluate system safety and health hazards, define risk levels, and manage the probability and severity of all hazards associated with the development, use, and disposal of the Spectral system. Health hazards shall be identified and include conditions creating significant risks of death, injury, acute chronic illness, disability, or reduced job performance of personnel who produce, test, operate, maintain, or support Spectral. The intern shall monitor, comply, and manage with the System Safety Program Plan to include evaluating the system safety process. The intern shall conduct analyses to identify and quantify hazards in hardware, software, and human interfaces and submit the results of the analyses in the System Safety Hazard Analysis Report. Hazards shall be eliminated or controlled to acceptable level of risk in accordance with the SSPP. The intern shall monitor and comply the Lead-Free Control Plan that documents processes which shall assure system components, that contain lead-free solder, satisfy the system performance, reliability, safety, and certifiability throughout the system lifecycle.

The intern should have a working knowledge of the following areas:

Electronics System Safety Management; Hazardous Materials (HAZMAT) Management; Pollution Prevention Management; Deactivation, Demilitarization, and Disposal Management; Lead Free Control Management.
