

SUMMARY ANNUAL REPORT

For Marsh & McLennan Companies, Inc. Health & Welfare Benefits Program

This is a summary of the annual report of the Marsh & McLennan Companies, Inc. Health & Welfare Benefits Program, EIN 36-2668272, Plan No. 501, for period January 1, 2013 through December 31, 2013. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The Plan has contracts with Metropolitan Life Insurance Company, Hawaii Medical Service Association, Kaiser Foundation Health Plans Inc., and Genworth Life Insurance Company to pay health, life insurance, HMO and PPO claims incurred under the terms of the Plan. The total premiums paid for the Plan year ending December 31, 2013 were \$6,797,153.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the Plan year ending December 31, 2013, the premiums paid under such "experience-rated" contracts were \$1,657,013 and the total of all benefit claims paid under these contracts during the Plan year was \$3,533,131.

Basic Financial Statement

The value of Plan assets, after subtracting liabilities of the Plan, was \$83,792,383 as of December 31, 2013, compared to \$82,148,537 as of January 1, 2013. During the Plan year the Plan experienced an increase in its net assets of \$1,643,846. This increase includes unrealized appreciation and depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the Plan year, the Plan had total income of \$242,683,432, including employer contributions of \$144,592,897, employee contributions of \$89,844,962, earnings from investments of \$4,357,991, and other income of \$3,887,582.

Plan expenses were \$241,039,586. These expenses included \$10,024,715 in administrative expenses, and \$231,014,871 in benefits paid to participants and beneficiaries.

Insurance Information

The Plan has contracts with Hyatt Legal Plans, Inc., National Union Fire Ins. Co. Of Pittsburgh, Pa, Connecticut General Life Insurance Company, Vision Service Plan, Metropolitan Life Insurance Company, Hartford Life Insurance Company and National Union to pay health, vision, life insurance, long-term disability, indemnity, legal, permanent total disability, paralysis and accidental death and dismemberment claims incurred under the terms of the Plan. The total premiums paid for the Plan year ending December 31, 2013 were \$5,099,600.

Because they are so called "experience rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the Plan year ending December 31, 2013, the premiums paid under such "experience –rated" contracts were \$2,190,481.
